**ASSESSMENT & AGREEMENT**

I hereby certify that my dog(s) is/are in good health and have not been ill with a communicable disease in the last 30 days.

I certify that my dog(s) is/are currently up to date on all vaccination requirements deemed necessary by RAE-ZOR GBD which include: **Distemper/Parvo (DHPP), Bordetella/kennel cough (6 month booster), fecal exam (negative), Canine Influenza, and Rabies.** I give permission to RAE-ZOR GBD for verification with my vet clinic.

I further certify that my dog(s) has/have not harmed or shown aggressive or threatening behavior towards any person or any other dog.

I acknowledge that by signing up for daycare/playtime my dog will be socialized with other dogs under the supervision of a RAE-ZOR GBD employee.

I acknowledge all dog(s) entering the facility will be subject to a health and temperament assessment. This is required for the staff to gain knowledge on how best to care for each individual guest. **NO GUEST WILL BE TEMPERAMENT TESTED WITH OTHER DOGS UNLESS SIGNED UP FOR DAYCARE OR PLAYTIME. ALL ONE ON ONE SESSIONS ARE WITH EMPLOYEES ONLY.**

I understand that I am solely responsible for any harm or illness caused by my dogs(s) attending daycare or other activities.

I further understand and agree RAE-ZOR GBD staff will not be liable for any problems that develop provided reasonable care and precautions are followed, and I hereby release them of any liability of any kind whatsoever arising for my dog(s) attendance and participation at the facility.

I agree to notify RAE-ZOR GBD if my dog(s) is/are diagnosed with a communicable illness and will keep him/her at home if I am aware of the symptoms.

I further understand and agree that any problems that develop with my dog(s) will be treated as deemed best by the staff of RAE-ZOR GBD, and I assume full financial responsibility for any and all expenses involved.

RAE-ZOR GROOMING BOARDING DAYCARE, INC reserves the right to refuse or terminate admittance of any dog, at any time, deemed unsuitable for this environment.
